

[**FUJITEC** will send maintenance officer regularly on specific date every once a month in the day already agreed by the parties, to undertake the following works:]
- a. Memeriksa dan membersihkan *brake sleeve, brake shaft, brake plunger* dan *brake wheel*;  
[Check and clean *brake sleeve, brake shaft, brake plunger* and *brake wheel*]
- b. Memeriksa, memberikan pelumas dan menyesuaikan mekanisme rem;





- o. Membersihkan pelumas dan mengatur penutup dan tuas pintu;  
[Clean lubricate and adjust door closer and lever]
- p. Membersihkan bagian atas sangkar, *landing door* dan *doorsills*;  
[Clean car top, car door, landing door and doorsills]
- q. Memeriksa dan mengganti lampu indikator pendaratan, tombol pendaratan dan lampu pada tombol keterangan;  
[Check and replace landing indicators bulbs, landing push buttons and enunciator light]
