1. Cancellation

All sales made cannot be cancelled by Buyer except upon terms and conditions acceptable to PT. Restomart Cipta Usaha as evidenced by written consent from PT. Restomart Cipta Usaha. Unilateral cancellation by Buyer will not reduce the obligation of Buyer to make the full payment of total sales which has been agreed on Order Confirmation.

2. Price Payment Terms and Methods

All transactions are processed in Rupiah currency. Price stated is inclusive of value added tax (PPN). Payment must be made according to Term of Payment agreed on Order Confirmation. Payment must be made in full accordance with the listed price without any deductions of administrative fee and income tax (PPH). PT. Restomart Cipta Usaha will reimburse the amount of tax deductions after receiving the certificate of withholding tax from Buyer. All payment must be made in the form of non-cash payment method, as such by bank transfer, m-banking, Internet banking or cheque. All payment made by Buyer is required to be confirmed by enclosing bank transfer receipt to Account Receivable Staff of PT. 3. Delivery, Claims and Force Majeure

4. Warranties

- o Products installed by other party apart from PT. Restomart Cipta Usaha, except by the third party which is appointed in written instruction by PT. Restomart Cipta Usaha to perform the Product installation.
- o Negligence from Buyer for neglecting Standard and Installation Requirement (SRI) informed by PT. Restomart Cipta Usaha (refer to the attachment of SPI).
- o Products have been modified or repaired by other party.
- o Product damages during delivery process which is performed by third party (transportation companies).
- o Product damages caused by the operation of Product apart from standard use guidelines and instruction manual book
- o Unable to show the official warranty card.
- o Products purchased from third party or other distributor which are not officially appointed by PT. Restomart Cipta Usaha.

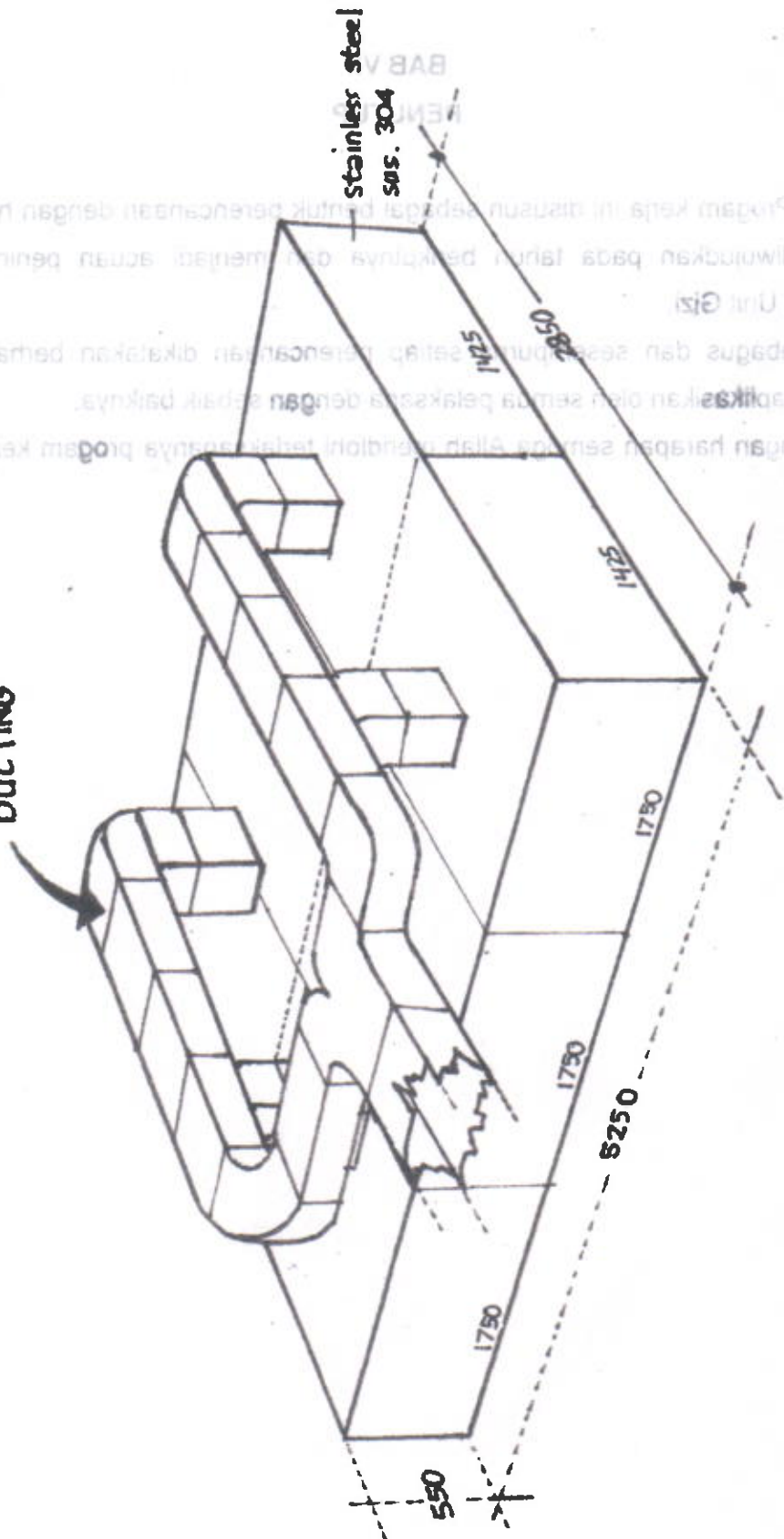
